The meeting convened at 10:30 a.m.

With respect to cases C-72-75, C-184-75, C-187-75 and C-188-75, the Commission directed that the letter to the respondents informing them of the Commission's determination make reference to the candidate's reliance upon an attorney and the attorney's admission of some responsibility for the non-timely filing or non-filing.

The Commission then reviewed the following cases from the 1975 May Municipal Election: Roy Haack (C-65-75) and William Meisner (C-64-75). The Commission directed the Executive Director to send a letter to each of these respondents requesting additional information as to the total expenditures made in their respective campaigns and deferred a determination in each case to permit time for a response to the Executive Director's letter.

4. Adjournment - The Commission adjourned the meeting at 2:30 p.m.
